

KOBERT IN WARRANTY

BARIPERFIL S.L. Tax Identification Number B433601913 - Trade Register of Tarragona, Folio 172 Volume 1557 Book of Public Limited Companies, Section 1, page T-20066.

The KOBERT IN plate has a 10-year guarantee, covering the durability of the plate with its containers. Protective inks and varnishes.

The warranty is for the end consumer and is not transferable. In order to exercise the right to the guarantee, it shall be taken into account that the product is subject to annual depreciation due to wear and tear, based on the following percentages calculated from the date of purchase: 1/5 per year for commercial use and 1/15 per year for domestic use.

The warranty is valid as long as the customer complies with the installation and maintenance requirements detailed by the company both in the "Installation Guide" and in the installation video tutorial. <https://bariperfil.com/tutorial-de-montaje/>

The requirements to be fulfilled in order to obtain the Guarantee (according to the "Installation Guide") are as follows:

1. KOBERT-IN, due to the nature of its composition, must spend a minimum of 24 hours acclimatizing in the place where it is to be installed.
2. The adhesives recommended in the installation guide must be used, in the case of not having these recommended products available for reasons of access to them, you will have to use products with the same technical characteristics, using very different products can lead to problems with the installation.
3. The material must be installed on the types of support indicated as suitable and following all the steps in the installation guide.

SUITABLE SUPPORTS: KB can be installed on painted walls (as long as the paint is well adhered to the wall and there is a smooth surface), on stoneware, porcelain tiles, painted plasterboard, on wood or boards as long as these are sealed with paint or varnish, etc ...

IMPORTANT NOTE: *KB can be installed inside spaces exposed to humidity, inside shower trays or bathtubs, but following the instructions specified in the TUTORIAL.*

NOT SUITABLE SUPPORTS: We cannot install KB:

- Walls with constant humidity.
 - Plaster walls with weak paint.
 - In exterior areas.
 - Areas subject to extreme temperature changes.
4. Before installation, the wall on which the product is to be installed must be completely clean, dry and even.
 5. The installation must be carried out according to the steps indicated in the Installation Guide.

6. The cleaning of the coating must be carried out with a damp cloth, not using abrasive materials or chemical products that may alter the design of the parts.

Damage caused by the following are **excluded** from this guarantee:

1. Incorrect handling, processing and placement of the product.
2. Damage resulting from daily use that may present slight damage after a prolonged period of time (scratches, knocks, etc).
3. Damage caused by cleaning with aggressive mechanical (brushes, abrasive scouring pads) or chemical (solvents, acids, etc) elements.
4. Soiling of the piece due to adhesive, putty, etc. Used during or after installation.
5. Damage caused by collisions with blunt objects that may cause scratches or buckling.

This warranty does not cover lost time, inconvenience, incidental expenses (such as telephone calls) resulting from the removal and reinstallation of siding for affected material, nor does it cover any other incidental or consequential damages.

The warranty will only be valid on presentation of the purchase invoice and must be completed with full details of the purchaser, seller and stamp of the establishment. Should you need to make a claim, you must do so through the shop where BA was purchased.

This warranty does not cover lost time, inconvenience, incidental expenses, (such as telephone calls) resulting from removal and reinstallation of the liner for affected material, nor does it cover any other incidental or consequential damages.

This warranty does not include costs for labor or installation of replacement siding nor does it cover damage due to improper installation or maintenance; alkalis in the substrate on which it is installed or conditions caused by hydrostatic pressure, burning, tearing, cracking, staining, or loss of luster from normal use or outdoor use.

The customer shall forfeit all claims if the delivered products are modified, transformed, manipulated or processed in an improper manner.
